TOWN OF COWPENS REGULAR COUNCIL MEETING May 21, 2018

The Town of Cowpens held its regular council meeting on Monday, May 21 2018, at 6:00 p.m. Present were Mayor Michael D. Hamrick, Mayor Pro-Tem Brenda J. Adair, Council Members Roy Logan, and Jarred S. Spencer, and Thomas Voelker.

Mayor Hamrick called the meeting to order and held prayer and included a moment of silence for the families of area residents who had lost loved ones and those who have sickness in their families.

Approval of Agenda

Brenda J. Adair made a motion approve the agenda for May 21, 2018, second by Roy Logan and carried.

Approval of Minutes & Financial Statements

Council discussed the minutes of April 16, 2018 and May 15, 2018. Roy Logan made a motion to approve the minutes, second by Thomas Voelker and carried.

Brenda J. Adair made a motion to approve the purchase journals, account registers, and monthly bank statements, second by Roy Logan and carried.

Department Reports

The police department issued 71 citations during the month of April 2018 and 52 warnings. Fines collected totaled \$6,179.50. The town's portion was \$1,636.33.

Steve Bolin reported the number of fire calls for the fire department, as well as mileage for each department. The fire department answered 31 calls for the month of April 2018. Eleven calls were in the Town, ten calls in the fire district, six calls were mutual aid in Spartanburg County, and four calls in Cherokee County.
