Approval of Agenda

Jarred S. Spencer made a motion approve the agenda for June 17, 2019, second by Roy Logan and carried.

Approval of Minutes & Financial Statements

Council reviewed the minutes of May 20 2019, purchase journals, accounts registers, and monthly bank statements. Brenda J. Adair made a motion to approve the minutes, second by Jarred S. Spencer and carried.

Department Reports

The police department issued 44 citations during the month of May and 38 warnings. Fines collected totaled \$3,228.00. The town's portion was \$1,079.78.

Mileage for each department included: Police – 9,455, Street Department –2,724 and Fire Department – 520.

Steve Bolin reported the number of fire calls for the fire department. The fire department answered 18 calls for the month of May 2019. Five calls were in the town, five calls in the fire district, seven calls were mutual aid in Spartanburg County, and one all in Cherokee County.

Street Department Truck
