TOWN OF COWPENS REGULAR COUNCIL MEETING June 18, 2018

The Town of Cowpens held its regular council meeting on Monday, June 18, 2018, at 5:30 p.m. Present were Mayor Michael D. Hamrick, Mayor Pro-Tem Brenda J. Adair, Council Members Roy Logan, and Jarred S. Spencer, and Thomas Voelker.

A public hearing was conducted to provide information to the public for the 2018-2019 fiscal year budgets.

Mayor Hamrick called the meeting to order and Brenda J. Adair held prayer and included a moment of silence for the families of area residents who had lost loved ones and those who have sickness in their families.

Approval of Agenda

Approval of Minutes & Financial Statements

Department Reports

The police department issued 39 citations during the month of May 2018 and 54 warnings. Fines collected totaled \$5,389.00. The town's portion was \$2,252.49.

Steve Bolin reported the number of fire calls for the fire department, as well as mileage for each department. The fire department answered 13 calls for the month of May 2018. Two calls were in the Town, eight calls in the fire district, two calls were mutual aid in Spartanburg County, and one call in Cherokee County.
