Steve Bolin reported the number of fire calls for the fire department. The fire department answered 32 calls for the month of July 2018. Nine calls were in the Town, 14 calls in the fire district, nine calls were mutual aid in Spartanburg County, and three calls in Cherokee County.

The police department issued 37 citations during the month of July 2018 and 39 warnings. Fines collected totaled \$3,088.75. The town's portion was \$986.48.

Chief Meredith received an Award letter today for a Body Worn Camera grant to upgrade the cameras, in the amount of \$7,900.00. This includes the purchase of two points of storage, one on site and one off site. He is also in the process of installing the Spillman program for the department.
